Privacy Policy for Dalmatian Club of Scotland Websites

1. DATA

The Dalmatian Club of Scotland Organisation ("DalScot" or "We" or "Us") does not via its websites attempt to collect personal information such as your name, address, phone number or email address; unless this information is submitted by you via a specific information capture form. In situations where this information has been submitted by you it is held for communication purposes only. In situations where our application or services interact with your Social Networks accounts we do not collect or store any personal information from them.

We do not knowingly contact or collect personal information from children under 12. If you believe we have inadvertently collected such information, please contact us so we can promptly obtain parental consent or remove the information.

2. ACCESS

Information we have stored can be requested for deletion. You can contact us by methods detailed below to request to have this information deleted.

3. DELETION

Except where users have requested data deletion we may keep data indefinitely.

4. SHARING

We do not share personally identifiable information (such as name, address, email or phone) with other companies or organisations unless forced to do so by law.

5. AD TRACKING

We do not allow advertising companies to collect data through our service for ad targeting.

6. CONTACT

7. SECURITY

We take reasonable steps to secure your personally identifiable information against unauthorized access or disclosure. However, no security can be guaranteed to protect information from hackers or human error.

Information we collect may be stored or processed on computers located outside the European Union.

8. SPECIAL CIRCUMSTANCES

we also may make identifiable and anonymous information available to third parties in these limited circumstances: (1) with your express consent, (2) when we have a good faith belief it is required by law or (3) when we have a good faith belief it is necessary to protect our rights or property. Your consent will not be required for disclosure in these cases, but we will attempt to notify you, to the extent permitted by law to do so.
